Nominations are hereby called for the positions of Directors for your Chamber of Commerce.

The Greater Saskatoon Chamber of Commerce is the voice of business for Saskatoon and a meaningful and impactful advocate for it. Directors of the Chamber fulfil the vitally important and exciting roles of representing the Saskatoon business community and leading real efforts to influence the path of prosperity for this great community.

The Board of Directors consists of up to fourteen (14) members who are responsible for mobilizing the resources of the community to achieve Chamber objectives. The Greater Saskatoon Chamber of Commerce is led by its Vision and Mission, as follows:

The Board of Directors meets up to 11 times per year for approximately 1½ hours at a time. The Executive, comprised of up to seven Board members, meets 11 times per year for approximately 1½ hours at a time. Each Director is expected to sit on at least two Chamber committees during their term of office. Time commitments can vary, but will generally average 3-5 hours per month.

When nominating a member for the Board, please consider their strengths, passion for, and contributions as they relate to meeting the Vision and Mission of the Chamber, as well as to their proven experience and ability to govern an organization.

The names of those nominated will be placed on a ballot which will be sent to all members, to be marked and returned. The **six (6)** nominees receiving the highest number of votes will be declared elected for a two-year term. In accordance with the By-Laws of the Greater Saskatoon Chamber of Commerce, the newly elected officers will be formally installed at the Annual General Meeting to be held on May 23, 2019.

The nomination form must be signed by two Chamber members and the nominee. Nominations must be received by the Chamber of Commerce at 110-345 4th Avenue South, Saskatoon, SK, S7K 1N3 by 12:00 noon on Thursday, March 14, 2019.

The ballot for election to the Board of Directors will be distributed on or before April 24, 2019. Your completed ballot must be returned on or before 12:00 NOON on May 10, 2019.
